7.6 Approval of Chromebook Purchase – Dr. Bridges reported that Ms. Maxedon, Ms. Robertson, Mr. Dresser & Dr. Bridges worked on the Chromebook quote. The district asked that all vendors bid on both Chromebook products that were considered. GovConnection was the vendor with the lowest bid. With this Chromebook purchase, the District will be very close to our goal of having one Chromebook per student. We will have approximately 2,000 Chromebooks in the District.

7.7 Food Service Audit / A La Carte Menu Change – Ms. Maxedon noted that the food service department was audited and there were some exceptions noted. The audit items mainly dealt with site specific issues. A new requirement for a la carte foods (non-program foods) has affected our ratios for compliance with snacks. Going forward the District will not offer a la carte items except for water, milk and second servings. Second servings are only available on pizza days. Second chance breakfast will still be available for the student’s nutritional break in the morning for \$1.50. Students will still have an option to get food at nutritional breaks and these nutrition breaks will now be healthier. This information will be communicated to parents via mail close to the time that we send out our Welcome Back Package.
