7.6      Jefferson School District 2017-2018 Budget- Mindy Maxedon, highlighted new aspects of the 2017-2018 budget. Ms. Maxedon noted that budgets adopted after 2015-16 require reserve disclosures to be provided for public review and discussion. The disclosures include minimum recommended reserve for economic uncertainty, combined assigned and unassigned ending fund balances that are in excess of the minimum recommended reserve for economic uncertainties for each fiscal year identified in the budget, and a statement of reasons that substantiates the need for an assigned and unassigned ending fund balance that is in excess of the minimum recommended reserve. Ms. Maxedon indicated that some of the reasons we need reserves are to protect against economic downturns, declining enrollment, gaps in LCFF funding and increased unplanned expenses. Summaries of the district’s reserves were provided as well as budget assumptions for the 2017-2018 year. Ms. Maxedon noted that the books will be closed for the 2016-2017 fiscal year in August, 2017. Unaudited Actuals will be presented at the September board meeting. The Board discussed options about how to manage the out years and the budget to be sure that reserves for the out years will be sufficient.
