## 5.1 Student Body Reports –

Jefferson's Student Body President, Pierson McLean, reported on the events at Jefferson School – Today marks the second anniversary of the dedication and reopening of the Jefferson School. In honor of the anniversary there are many monthly activities planned. Right now Jefferson School has "Kindness Week" where students will have motivational quotes each morning and a kindness challenge. Also, each grade level will watch the movie, "Wonder", in the theater. To end this week there will be an Enchanted Evening Dance catered by Town & Country. Arising actors and actresses are preparing to audition for the school play. On February 2<sup>nd</sup> a spirit day will be held to honor the Super Bowl. To show support for the Bowl, students will wear either white and green to support the Eagles or blue and red to support the Patriots. Later this month the Bull Dog Project will be giving a speech about bullying and its effects.

Monticello – ASB Vice President, Aubrea Davis, shared the news from Monticello– Monticello just started the Jaguar Den. That Jaguar Den is a store where students can spend tickets they've won to buy items. There was an "Inside out/Backward" spirit day on January 19<sup>th</sup> and the upcoming spirit day will be "Flashback Friday" which will be held on February 9<sup>th</sup>.

Anthony Traina – Brooklynn Walden and Mariyah Ramirez shared the activities at Traina School over the past month as the ASB representatives were unable to attend the board meeting. There was a "2018 Kick-Off Bling" spirit day where students wore 2018 hats, shirts and more to celebrate the new year. On Friday, January 19<sup>th</sup>, there was an "Alice in Wonderland" dance. This was the first dance this year with a D.J. for the 6<sup>th</sup>-8<sup>th</sup> grade students. There were different tables decorated with themes of "Alice in Wonderland" characters. There was a table for Alice, the Mad Hatter, the Cheshire Cat, the White Rabbit, Tweedle Dee and Tweedle Dum. Ms. Walden and Ms. Ramirez shared some of the things that students have been studying this past month. Eighth grade students are studying the Bill of Rights, and finishing up the unit on the holocaust. Seventh graders are learning to write myths in English Language Arts. 7.2 Food Services Department Update – Director of Food Services, Debbi Rogers, thanked her department and indicated how incredibly proud she is of them. Ms. Rogers also noted that she is very proud of Sabu Abraham because he was Jefferson School District's employee of the year and County Employee of the Year. Since last year's report, salad bars have been implemented and there is nothing negative to say about them. Both parents and students alike enjoy the salad bars. Last year, they stopped selling second snacks and started selling breakfast. In 2015-16 the department sold 23,130 free meals and in 2016-17 that number increased to 31,522 meals served. Reduced meals went from 4,000 served in 2015-16 to 8,500 served in 2016-17. Ms. Rogers shared statistics of direct

served meals as well which also showed marked increases. She noted that the online Free and Reduced application process has increased from 105 total online applications last year to 165 applications already this year. Thanks to direct certification and Medicaid talking to CalPads, more students who need assistance are receiving the services that they need with regards to food services. Ms. Rogers noted that the whole point of the Food Services Department is finding avenues to be sure that they can feed the students who need it and they are doing just that.
