Superintendent's Report – On February 21st - Dr. Bridges attended the first meeting of the History/Social Studies adoption committee. Over the next few weeks, Mrs. Steen has scheduled different publishers to present to the team.  - 5.1 Student Body Reports –

On the same day Jefferson celebrated with a Winter Olympics Rally, and the choir did an amazing job singing the National Anthem. Coming soon to the Jefferson School Theater "Alice in Wonderland" will be performed by students. On April 13th, there will be a 50's themed spirit day and dance where students will have a blast from the past. The Jefferson/Monticello Science Night is coming soon and there will be lots of fun activities to do.

Monticello – ASB Vice President, Aubrea Davis, shared the news from Monticello– the 4th grade went on a field trip to Gallo Center in Modesto where they learned a lot about music and were able to play their recorders. Next month students will go to Sacramento on a gold rush field trip and students are very excited about the trip. The next spirit day coming up will be Twin Day.

Tom Hawkins – ASB President, Claire McLeod, reported for Hawkins School – On February 23, a Hollywood themed semi-formal dance was held and it was a success. 7.2 2017-18 Second Interim Report - CBO, Mindy Maxedon, shared the highlights of the 2017-18 Second Interim Report. The Second Interim report includes updated revenue of \$972K in 2018-19 to reflect full implementation of the Local Control Funding Formula (LCFF). The assumptions acknowledge a possible decline in enrollment of 60 students due to the Interdistrict transfer policy change of a neighboring school district. Dr. Bridges has been working with the neighboring district and hopefully the decline in students won't be as bad as previously thought for 2018-19. The revenue assumptions do not include one-time revenue of \$295 per ADA for the 2018-2019 school year. The District will have more information and possibly revised ADA projections after the May Revise and budget report.

Expenditure highlights include backing out teacher expenses as the District will be down 3 teachers related to anticipated decline in ADA. The District is budgeting for another Professional Learning Community (PLC) workshop to take 31 teachers this summer, 2018. The budget was updated for the anticipated adoption of History/Social Science. The District is also budgeting for GLAD and eRate.

The Local Control Accountability Plan (LCAP) draft is in process and 2018-19 Budget Development is also in process and will be available for the April or May meeting.

7.6 First Amendment – Tracy Hills Mitigation Agreement- John Palmer presented information regarding Tracy Hills. Mr. Palmer commended Mr. Dolinka & Dr. Bridges for the great relationship that Tracy Hills has had with the board. He explained there was some difficulty with the mitigation agreement regarding projections for delivering the school at the right time. Mr. Palmer conveyed Mike Souza's apologies as he was unable to attend.

Mr. Palmer shared a video and a slide show describing the Tracy Hills development. The development will have 5,500 homes as well as approximately 5.7 million square feet of non-residential usage (acreage set aside for industrial/commercial use). They are building Phase 1A now which is 411 acres, with approximately 1,139 homes being built. Phase 1A also includes a 14-acre school site. The goal is to have the model complex with park installed and opened by the end of this

year. If that falls into place, Tracy Hills is anticipating occupancy in the spring of 2019. They will likely have a fully funded school for the school year beginning 2021. Depending on how many students are generated from the development, once we reach capacity at the temporary school campus and our existing schools the new school will be built.
