Superintendent's Report – Dr. Bridges reported that this month's weather has allowed BHM Construction to progress greatly at Corral Hollow Elementary School. The kindergarten classrooms will be completely enclosed within the next two weeks. The siding is up, and stucco will be sprayed; roofing is on, and the windows are in.
