• Student Hearing 2018-10-01:

Motion by Board Member Debbie Wingo and seconded by Board Member Dan Wells, it is moved that the Board of Trustees expel Student No. 2018-10-01 from all schools in the District for violation(s) of Education Code sections 48915 (c.2) (Knife, Brandishing), 48900 (b) (Weapon Possession) and 48900 (a)(2) ("Possession of any knife or other dangerous object of no reasonable use to the pupil.") through May 29, 2018 of the 2018-2019 school year.

It is further moved that the Board conclude that:

a) Due to the nature of the offense, the Pupil's presence causes a continuing danger to the physical safety of the Pupil or others.

In support of these conclusions, it is moved that the Board make the findings of fact which were discussed by the Board and prepared in the course of our deliberations.

It is further moved:

- 1. That Pupil 2018-10-01 shall be reviewed on or after June 1, 2019 for readmission to a District school for the first semester of the 2019-2020 school year.
- 2. That during the period of the expulsion Student 2018-10-01 shall be provided With an alternative educations program at SJCOE ONE Program or California Connections Academy Schools.
- 3. That Pupil shall be subject to the rehabilitation plan recommended by the District.

IV. EDUCATIONAL SERVICES

5.1 Student Body Reports -

September 26th, an outdoor movie night was held. The weather was perfect and lots of kids, families and friends attended. The week of September 24th- 28th Parent/Teacher Conferences were held in the MPR. Parents received their student's report cards and had an opportunity to hear about their student's progress. Tomorrow is National Walk to School Day. Students and teachers will walk in wild colors. Real DUI Court will be this Friday for 7th -8th graders along with Jefferson and Traina students. The first dance of the year is this Friday for 6th -8th grade students. Ms. Coelho presented "thank you" letters from each of the Tom Hawkins band students to the Board for their new band equipment.

If approved, an "Intent to Participate Form" will be submitted asap with the hope that all forms will be returned by November 6th. 7.2 Tracy Little League Contract – Tracy Little League (TLL) President, Rob Simmons, spoke for the Tracy Little League. Mr. Simmons thanked the Board and Dr. Bridges for allowing him to speak at the meeting tonight. He acknowledged the problems with the fields at Monticello and noted that TLL's Board has approved to have a professional service take care of the fields. Mr. Simmons noted that they have set aside \$3,000 to fix the irrigation and common areas of the fields.

Mr. Carlson noted that the problem isn't just the grass but the facilities around it are not taken care of. Mr. Simmons noted that in the next month everything is going to be taken down and they will repaint and rebuild the container boxes. Mrs. Wingo mentioned that when the public sees the fields, the perception is that not that the Tracy Little League isn't taking care of the fields, it is that the Jefferson School District doesn't take care of our facilities and that isn't what we are about. Ted Butch from Tracy Little League was at the meeting and indicated his willingness to help TLL with the fields. The Board will revisit renewing the contract in a couple of months. No action taken.
