Superintendent’s Report – Dr. Bridges thanked the principals, teachers, site staff and D/O staff for kicking off the new school year successfully. Nancie Castro got a grant for the Ident-A-Kid systems which have been installed in all four school sites. The Ident-A-Kid system can track student tardies, students leaving early, and prints badges for parents who come in and visit. When people come to the office to volunteer they scan their driver’s license and their information is brought up. A background check is run and their name automatically prints on a name tag. Amplify is a new system that the District will be using. The District has done universal screening for students in DIBELS. Amplify allows testers to do their tests electronically. Students in grades 3-6 are able to test online and their test scores are immediately available in real time with no delay.
