5. UPDATE ON MEASURE J PROJECTS AND TIMELINE – The Traina School gymnasium contract was approved in November. Since then some drainage issues were addressed. Rain delayed the project further as did moisture level in the ground, which occurs naturally. Soil has been amended with a geo-grid barrier and a layer of soil. The soil is being tested this week which pushes the project completion date to February 1, 2016.

Regarding the Jefferson project, building A has ninety-percent of a roof. Framing, windows, and the cafeteria are the next areas where we will see action. The new gym's structure is well under way and the back parking lot is done. Rain shouldn't impact the project. Increment II, which included the water tank, is being readied for the contract.

In the area of technology spending, 600 Chromebooks are on order and will be distributed to sixth through eighth grade students. The technology carts were received.
