THE PURPOSE OF PAC





By the end of the 2026-2027 academic year, 100% of all general education classrooms will be led by teachers working collaboratively as a professional learning community (PLC) to provide common syllabi, common success criteria, and learning outcomes, and common assessments

By the end of the 2026-2027 academic year, 90% of all 3rd graders within our district will demonstrate proficiency in reading at grade level as measured by district assessments.


