3. Review COVID-19 Information
 - a. ELD support with online learning / school closures (site reps to share out)
 - i. Students used Imagine Learning and Read Naturally. Students demonstrated growth. Para/Aides sat in on teacher online lessons to support ELs. In direct communication with families throughout distance learning.
 - b. ELPAC summative testing was suspended (2019-2020).
