JESD utilized stakeholder input to develop the Expanded Learning Opportunities Grant Plan. The ESSER III Expenditure Plan will add to the learning opportunities made available and extend the length of time they are available to all students. Based on input received during school closures, community response showed that email and online surveys were a highly rated form of district communication. JESD sent out an email to inform all stakeholders about the grant available and the need for their input to develop a plan to provide services. The email included a survey asking all stakeholders to rank the seven priorities and provide input on ideas for implementing each strategy. The following strategies were ranked in order of importance: Extended Instructional Time, Tutoring/Intervention, Health/Counseling/Food Services, Access to Technology, Credit Recovery 6-8th, Assessment/Monitoring, Professional Development. The feedback from the survey was analyzed by the district leadership team to develop the plan. Community members consulted included:

- Students;
- Families, including families that speak languages other than English;
- School and district administrators, including special education administrators;
- Teachers, principals, school leaders, other educators, school staff, and local bargaining unit.

The district will continue to maintain instructional aide support in TK and Kinder classrooms. Professional development opportunities will continue to be made available to staff to support the needs of students who are not meeting grade level essential standards. Professional Learning Communities will continue the work to collaborate on the clear instructional vision and deliberate set of standards, grade level benchmarks, instructional strategies, and assessments. This collaborative approach will ensure all students work towards mastery of the grade level essential standards to ensure students achieve at high levels.

JESD will fund more opportunities to extend the learning day, the following actions from the Expanded Learning Opportunities Grant Plan will be continued: After school open libraries/labs, Assessment and progress monitoring, Professional development, Before and after school tutoring including study skills (in person and remote offerings), District Intervention Coordinator, Increased/Improved support for English Learners, Increased counseling services, Tier 3 intervention before and after school (Math & ELA), Behaviorist, Credit recovery options. Increase program offerings in our existing summer program.

Using the ESSER III funds, JESD has a thorough plan in place to address learning loss and support all students in the coming years. The district will continue to monitor progress with state and local data. The plan was developed in response to Community input. The plan has strategies in place to address the academic impact of lost instructional time through implementation of evidence based interventions.

The plan includes tiers of support with intervention opportunities occurring online and other offerings focused on remediation and enrichment. The assessments used provide real time data to identify areas of student learning that need to be addressed. Using the data and other tools, teachers planned instruction to meet the needs of all learners, including EL, low income, foster youth, exceptional needs students and homeless. Educators track and address expected grade level standards and skills by identifying needs, providing instruction and intervention

- Utilized data and aligned supports to student needs.

Ongoing analysis of assessment data will be used to continue to address pupil learning loss of all students including EL, low income, foster youth, exceptional needs students and homeless.

A safe learning environment will make it possible to ensure learning continues at high levels. Strategic intervention will be available when needed for foster youth, English learners, homeless youth, students with disabilities, low income students and students struggling academically. An online program will be made available to teachers and students for Social Emotional Learning to increase access to the wellness curriculum. The JESD community indicated a need for all new plans to address safely keeping schools open. To continue to operate schools safely for in person learning, JESD will look to open additional classrooms to allow needed student spacing. The district will also work to improve access to school facilities that allow touchless access. One improvement needed in this area is access to water stations. Actions that keep staff and students on campus support their access to the evidence base strategies in the plan.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

**Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
